

**HEARD COUNTY BOARD OF COMMISSIONERS MEETING
February 23, 2021 - 6:30 P.M.**

The Heard County Board of Commissioners held a Commissioners Meeting on November 17, 2020 at 6:30 p.m. in the Commission Chamber of the Heard County Administration Building. In attendance at the meeting were Chairman Lee Boone, District 1 Commissioner Larry Hooks, District 2 Commissioner James Perry, District 3 Commissioner Gwen Caldwell, District 4 Commissioner Larry Hammond, District 5 Commissioner David Walls, and County Attorney Jerry Ann Conner.

Agenda Item # 2 - Welcome, Invocation, and Pledge to the American Flag - Chairman Boone called the meeting to order, gave the invocation and welcomed everyone present.

Agenda Item # 3 – Presentation of Service Award- Chairman Boone presented Mr. Robert Nelms with his 40 years of service plaque.

Agenda Item # 4- Public Hearings- a. Road Abandonment- Chairman Boone explained that the road was never officially closed, but the road had been abandoned due to a closed bridge that did not get repaired. Mr. Loy Howard requested the road be formally closed to clear his title. On motion (Hooks) and second (Perry), the Board unanimously voted to close this public hearing.

b. Application to Rezone from Rural Development to Agricultural- 19770 Georgia Hwy. 100- Chairman Boone explained to the Board the Mr. Drake made the request to have 8 acres of property located at 19770 Ga Hwy. 100 rezoned from rural development to agricultural. On motion (Hammond) and second (Caldwell), the Board unanimously voted to close this public hearing.
